Objectives and investment policy

The sub-fund aims to achieve the highest possible return, relative to the risk taken by the sub-fund.

The sub-fund invests in fixed income and fixed income related securities issued by corporations, agencies, governments and municipalities. The securities primarily include corporate bonds, but also subordinated and covered bonds. Investments are expected to give the sub-fund a higher risk and return than traditional interest-bearing securities.

The sub-fund qualifies as an Article 9 product under SFDR since its investment strategy contains ESG objectives.

The sub-fund's investment strategy is designed to create long-term positive return in sustainable investment which combines the classic requirements of risk and financial return with the low carbon transition requirements in line with The Paris Agreement as signed on 22 April 2016 (the Paris Agreement) and the Sustainable development goals ("SDGs") developed by the United Nation. The sub-fund is managed taking into consideration corporate responsibility and sustainable development principles in accordance with:

- The UN Principles for Responsible Investment ("PRI")
- The guidelines for the Norwegian Government Pension Fund Global.

The sub-fund will not make investments which constitute an unacceptable risk that we may contribute to unethical acts or omissions. In addition, the sub-fund must comply with the requirements of the Nordic Swan Ecolabel and

will pick companies based on the positive inclusion criteria. More information on how the Investment Manager selects sustainable investments can be found at its website www.paretoam.com.

The sub-fund has a global investment universe, but invests predominantly in developed markets.

The average duration shall be between 0 and 7 years.

The sub-fund may use financial derivative instruments (FDI's), such as forward rate agreements, futures, options, swaps, CDS (Credit Default Swaps) and other derivatives for both hedging and investment purposes.

The sub-fund is actively managed without reference to a benchmark.

The reference currency of the sub-fund is SEK.

The currency of the share class is USD.

Under normal circumstances, you may sell your shares any day on which banks are open for business in Luxembourg, Norway and Sweden, except 24 December.

These shares are capitalisation shares. Income and capital gains are reinvested.

Recommendation

This sub-fund may not be appropriate for investors who plan to withdraw their money within 2-3 years.

Risk and reward profile



What does this synthetic risk and reward indicator mean?

- The shares of class H USD are classified in category 4 because the value of the share may be subject to medium variations and consequently the risk of loss and the opportunity of gain may be moderate.
- The risk category for this share class was calculated using simulated and historical data. The risk category may not be a reliable indicator of the share class's future risk profile. The risk category shown is not guaranteed and may change over time.
- The seven-category scale is complex, for example 2 is not twice as risky as 1. The gap between 1 and 2 might not be the same as the gap between 5 and 6. A category 1 sub-fund is not a risk-free investment - the risk of losing your money is small, but the chance of making gains is also limited.

Which materially relevant risks are not adequately captured by the synthetic risk and reward indicator?

- Credit risk: the sub-fund invests directly or indirectly in interest bearing instruments, for example bonds. If an issuer of such an instrument cannot pay interest or the nominal amount at maturity, the investment can lose some or all of its value.
- Liquidity risk: low liquidity might result in that it would be difficult or

impossible to buy or sell an investment instrument in a timely manner and that the price could be lower or higher than expected.

- Currency risk: the sub-fund may hold some of its investments in currencies other than the sub-fund's reference currency. Thus the value of the sub-fund may rise and fall due to currency movements.
- The sub-fund may use derivatives. Due to their structure, the risk associated with these investment instruments may have a larger impact on the value of the sub-fund, than buying the underlying stock or investment instrument directly.
- Counterparty risk: the risk that a counterpart does not fulfill its obligations to the sub-fund (e.g. not paying an agreed amount or not delivering securities as agreed).
- Operational risk: the risk of loss resulting from e.g. system breakdowns, human errors or from external events.
- Sustainability Risk: the broad ESG goals of this sub-fund may lead the Investment Manager to exclude securities for non-financial reasons, irrespective of market opportunities in order to achieve the stated ESG Goals. The financial returns of this sub-fund may not be equivalent or surpass those of non-ESG financial products.

Charges

The charges you pay are used to cover the running costs of the sub-fund, including the costs of marketing and distribution of shares. These charges reduce the potential increase in value of an investment in this sub-fund.

The conversion of some or all of the shares into shares of another sub-fund or another share class is free of charge.

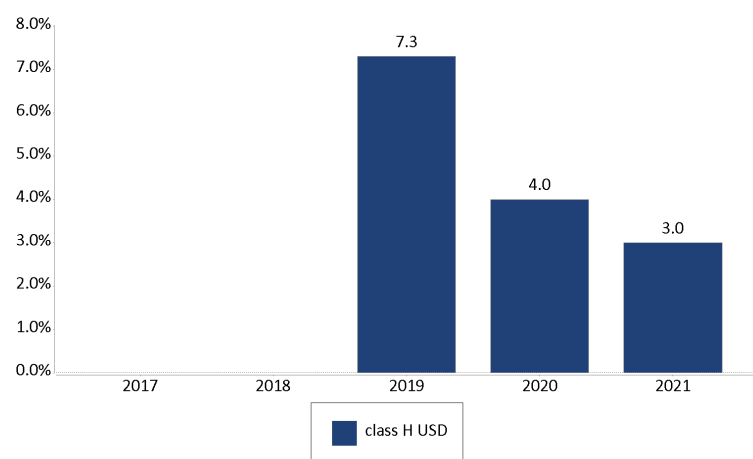
The ongoing charges figure shown here is an estimate of the charges. The fund's annual report for each financial year will include detail on the exact charges incurred.
