

# Key Investor Information

### Objectives and investment policy

The sub-fund aims to achieve the best possible return, relative to the risk taken by the sub-fund.

The sub-fund invests in fixed income and fixed income related securities issued by financial institutions, corporations, agencies, governments and municipalities while incorporating ESG criteria into the Fund's security analysis and selection criteria. These debt securities may include subordinated, hybrids, perpetual, convertible bonds and contingent convertible bonds. The sub-fund may invest up to 20% of its Net Asset Value in CoCos. Some investments of the sub-fund are expected to give it a higher risk and return than traditional securities due to a higher credit risk. The debt securities may be rated or unrated and have credit risk corresponding to investment Grade or High Yield. The sub-fund may hold distressed debt securities or shares as a result of a restructuring. The sub-fund primarily invests in securities issued by companies domiciled or with a presence in the Nordic region.

The average interest rate duration of the sub-fund's portfolio shall be between 0 and 4 years.

The sub-fund may not invest more than 10% of its assets in other investment funds.

The sub-fund invests in derivatives to achieve its investment objective or to reduce risks.

The sub-fund qualifies as an Article 8 financial product under SFDR since its investment policy contains broad environmental, social, and governance consideration in which are in line with:

- The UN Principles for Responsible Investment ("PRI")

- The guidelines for the Norwegian Government Pension Fund Global

Pareto Asset Management may decide to exclude a company if there is an unacceptable risk that the company contributes or is responsible for: Human rights violations, Violations of individuals' rights in war or conflict situations, Breach of basic employee rights, Severe environmental damage, Actions or omissions that lead to greenhouse gas emissions at an aggregated company level, Corruption, Other repeated or significant violations of basic ethical norms. The sub-fund also avoids companies which are significantly harming any of the environmental objectives set out in the Taxonomy Regulation. The sub-fund will favour investments that contribute to a viable transition towards reduced carbon emissions. The sub-fund is actively managed without reference to a benchmark.

The currency of the share class is NOK.

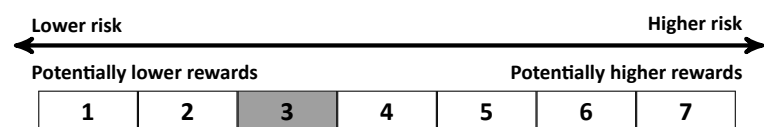
Under normal circumstances, you may sell your shares any day on which banks are open for business in Luxembourg, Norway and Sweden, except 24 December.

These shares are capitalisation shares. Income and capital gains are reinvested.

#### Recommendation

This sub-fund may not be appropriate for investors who plan to withdraw their money within 1 - 3 years.

### Risk and reward profile



#### What does this synthetic risk and reward indicator mean?

- The shares of class H-I NOK are classified in category 3 because the value of the share may be subject to medium variations and consequently the risk of loss and the opportunity of gain may be moderate.
- The risk category for this share class was calculated using simulated and historical data. The risk category may not be a reliable indicator of the share class's future risk profile. The risk category shown is not guaranteed and may change over time.
- The seven-category scale is complex, for example 2 is not twice as risky as 1. The gap between 1 and 2 might not be the same as the gap between 5 and 6. A category 1 sub-fund is not a risk-free investment - the risk of losing your money is small, but the chance of making gains is also limited.

#### Which materially relevant risks are not adequately captured by the synthetic risk and reward indicator?

- Liquidity risk: low liquidity might result in that it would be difficult or impossible to buy or sell an investment instrument in a timely manner and that the price could be lower or higher than expected.

- Currency risk: the sub-fund may hold some of its investments in currencies other than the sub-fund's reference currency. Thus the value of the sub-fund may rise and fall due to currency movements.

- The sub-fund may use derivatives. Due to their structure, the risk associated with these investment instruments may have a larger impact on the value of the sub-fund, than buying the underlying stock or investment instrument directly.

- Counterparty risk: the risk that a counterpart does not fulfill its obligations to the sub-fund (e.g. not paying an agreed amount or not delivering securities as agreed).

- Operational risk: the risk of loss resulting from e.g. system breakdowns, human errors or from external events.

- Sustainability risk: The broad ESG Goals of this sub-fund may lead the Investment Manager to invest in or exclude securities for non-financial reasons, irrespective of market opportunities in order to achieve the stated ESG Goals. The financial returns of this sub-fund may not be equivalent or surpass those of non-ESG financial products. Data constraint is a big challenge and there are limitations on the types of sustainability and ESG-related data currently provided to the market.

## Charges

The charges you pay are used to cover the running costs of the sub-fund, including the costs of marketing and distribution of shares. These charges reduce the potential increase in value of an investment in this sub-fund.

The conversion of some or all of the shares into shares of another sub-fund or another share class is free of charge.

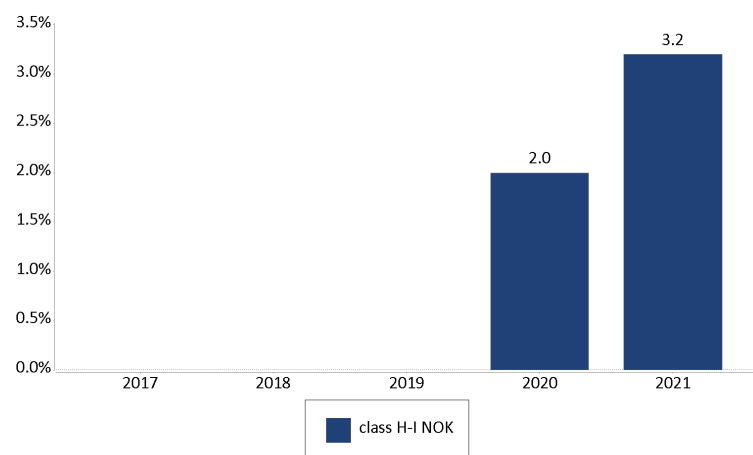
The ongoing charges relate to the annual charges; they were calculated on 31.12.2021. The ongoing charges may vary from year to year.
